By submitting, and by our publishing an specific and/or ongoing work with consent as outlined herein, the Author grants SSWUG.ORG and Bits on the Wire, Inc. all rights, title and ownership in the work, including worldwide, perpetual, exclusive rights to use and publish the Author's specific and/or ongoing work(s) by any means in any format or medium so deemed by the Publisher.

Publication of specific and/or ongoing works is at the sole discretion of the Publisher. The Publisher will have a final determination of whether the Author's specific and/or ongoing work has been accepted for publication within 90 days of your submission. If the Author's specific and/or ongoing work is not selected for publication, all rights, title and ownership in that specific and/or ongoing work returns to the Author.

The Author certifies, warrants and represents that the specific and/or ongoing works, scripts or other information submitted by the Author to the site are the intellectual property of the Author, that the Author is the sole author of the work and that the Author has the right to submit the specific and/or ongoing work for publication on SSWUG.ORG and on sites owned by Bits on the Wire, Inc. The Author cannot re-use diagrams, graphics, lengthy examples and/or code samples from other author's work. If it is necessary to change the date, the Author will receive an email with the date change notification.
